ORDER DIRECTING SERVICE BY PUBLICATION

Defendants.

THIS MATTER is before the Court on the motion of defendant Swift Aviation Group, Inc. ("SAG"), for an order directing SAG to effect service of process of its Cross-Claims by publication upon Bronwen Energy Trading UK, Ltd. ("Bronwen UK") and Dr. Patrick Denyefa Ndiomu ("Dr. Ndiomu") pursuant to N.C. Gen. Stat. § 1A-1, Rule 4(j3)(3) and Rule 4(j1). Section 1A-1, Rule 4(j3)(3) of the North Carolina Rules of Civil Procedure permits a defendant to be served outside the United States by any "means not prohibited by international agreement as may be directed by the court." SAG is requesting that the Court direct it to serve Bronwen UK and Dr. Ndiomu with SAG's cross-claim by publication in newspapers of wide circulation in the United Kingdom and in Mecklenburg County, North Carolina.

After considering SAG's Motion for Order Directing Service by Publication; its Memorandum in Support of Its Motion for Order Directing Service by Publication; the Affidavit

of Bryan Madagan; the Certificate-Attestation of the Supreme Court of England and Wales, Foreign Process Section; and the Affidavit of Meredith J. McKee, the Court finds as follows:

- 1. Despite diligent efforts to effect service through traditional means, SAG has been unable to serve its Cross-Claim on Bronwen UK or Dr. Ndiomu.
- 2. Because Bronwen UK is a limited liability company organized in the United Kingdom, and because Bronwen UK and Dr. Ndiomu were last found in London, service of process by publication in a newspaper of wide circulation in the United Kingdom is reasonably calculated to notify Bronwen UK and Dr. Ndiomu of the cross-claims and to afford them an opportunity to present their objections.
- 3. In addition, Bronwen UK and Dr. Ndiomu are aware that this lawsuit is pending in Mecklenburg County, North Carolina, because the Plaintiff served each of them with a copy of the Complaint and Summons. Dr. Ndiomu, the principal of Bronwen UK, later contacted counsel for the Plaintiff to discuss this lawsuit and then provided the Plaintiff with relevant documents.
- 4. As a result, service of process by publication in a newspaper of wide circulation in Mecklenburg County, North Carolina, the county in which the action is pending, is reasonably calculated under the circumstances to notify Bronwen UK and Dr. Ndiomu of the cross-claims and to afford them an opportunity to present their objections.

It is therefore ORDERED, for good cause shown, that:

a. SAG shall effect service of process on Bronwen UK by publishing a notice of service of process by publication for three consecutive weeks in *The Times* and *The Charlotte Observer*, widely circulated newspapers in London, United Kingdom and Charlotte, North Carolina, respectively, in substantially the following form:
